TRAINING FOR ALL to ensure SERVICE TO ALL

Haryana Institute of Public Administration (HIPA) envisions itself as an instrument to support the realization of citizen centric, responsive and good governance goal of the Government of Haryana.

HIPA is presenting its Annual Administrative Report for 2019-20 with a sense of pride and privilege. 
It aims to focus on quality, gender, e-Governance, employment and environment as major themes for supporting good governance in the state in coming years.

An amendment was made in the Memorandum of Association (MoA) at the Fifty-sixth Meeting of the Executive Council of HIPA held on October 14, 2009 that "the name of the Society shall be The Haryana Institute of Public Administration: A Centre of Good Governance."

FOUNDATION COURSES


First Joint Foundation Course (JFC) for HCS Officers and other Allied Services

For the first time, HIPA conducted a Joint Foundation Course for HCS officers and other Allied services from January 27 to March 16, 2020. The Chief Secretary of Haryana, Mrs. Keshni Anand Arora, while inaugurating the programme congratulated the trainee officers for joining these prestigious services and highlighted the features of the course which seek to foster qualities of professionalism, responsiveness, integrity and fortitude amongst civil servants. A total of 137 officer trainees comprising of HCS officers, Deputy SPs, ETOs, Assistant ETOs, DFSOs, Tehsildars and BDPOs among others attended the Joint Foundation Course.

Centre for Disaster Management

Disaster risks in Haryana are compounded by increasing vulnerabilities related to changing demographic and socio-economic conditions, unplanned urbanization, development in high risk zones, environmental degradation, climate change, geological hazards, epidemics and pandemic. All these contribute to a situation where disasters seriously threaten Haryana's economy, its population and developments. The Government of Haryana has brought about a change in the approach to disaster management from a relief- centric to a holistic and integrated approach covering the entire gamut of disaster management (Prevention, Mitigation, Preparedness, Response, Relief, Reconstruction and Rehabilitation). The approach is based on the conviction that development cannot be sustainable unless disaster mitigation is built in the development process. The disaster mitigation is basically a series of efforts to reduce disaster risk through physical development, awareness and capacity building. Awareness and Capacity Building is an ongoing process that equips officers and employees of the Government departments, PSUs, ULBs, PRIs and other stakeholders including communities to perform their functions in a better manner especially during a crisis/ disaster.

Sevottam Cell

Sevottam framework is a commitment to raise the standard of public service, enhance the customer's satisfaction, provide effective and efficient services besides bringing a continuous improvement in its services and its delivery processes. Accordingly, the Sevottam Cell was set up at HIPA.

In addition to the above, Sevottam Compliant Citizen's Charters have been drafted by Sevottam Training Cell and have been sent to the concerned departments for their consideration, updating and fine tuning keeping in view the recent initiatives and innovations of the departments and also the available feedback from the clients in respect to the following departments:

COMMIT - Comprehensive Online Modified Modules on Induction Training

It is a DoPT sponsored Capacity Building Project. It is a blended Training Programme with the objective to improve the public service delivery system and promote Good Governance and Citizen Centricity of Administration. Under COMMIT, all newly recruited frontline state government functionaries, who received no induction training for professional and personal development in the last five years shall be covered.

The advantages of such a programme will be providing opportunities to more officers, who have had limited or no training to build up the requisite skills, knowledge and attitude. The programme is 28 hours of blended training with 20 hours of e-learning and 9 hours of face-to-face training.

Centre for Entrepreneurship Development

The Centre for Entrepreneurship Development set up in HIPA in the year 1997-98, is a joint venture of Ministry of Micro, Small and Medium enterprises, Government of India and Government of Haryana. The basic objective of the centre is to assist the State Govt. in formulating policy and planning for Micro and Small industries and to promote entrepreneurial environment as an integrated package, with direct participation of different agencies at various levels to put the state on the map as a force in India's growing entrepreneurial eco-system.

The major activity of the centre is to organize EDPs of various durations on regular basis to create new entrepreneurs by cultivating their latent qualities of entrepreneurship and in lighting them on various aspects necessary for setting up micro and small enterprises. Besides its core activity of training, it takes other supporting services like research and consultancy, extension education, publications, information sharing etc.

At present the centre is running an Information Technology (IT) literacy course started by HKCL (Haryana Knowledge Corporation Limited), Government of Haryana. This course comprises of:

- 1. Reading and understanding a highly illustrated book
- 2. e-Learning based self-learning sessions
- 3. e-Learning Revolution for All (ERA)
- 4. Providing hands-on practice sessions.
- 5. Learning facilitation by certified professionals
- 6. Academic interactions, assessments and collaboration

After completing the course, the learners emerge as confident and versatile users of Information Technology. Upon successfully completing the course, learners are awarded the Haryana State - Certificate for Information Technology, jointly certified by Haryana Board of School Education, Bhiwani & Haryana Knowledge Corporation Limited, Panchkula. 33 students have already completed this course successfully.

RESEARCH AND CONSULTANCY

The Institute undertakes, promotes and coordinates research and analytical studies on its own and in collaboration with other Government and Non-government organizations. The research and consultancy services offered by the Institute basically aim at problem diagnosis, preparation of action plans and redesigning and restructuring systems. The institute offers research and consultancy in the following areas:

- Monitoring and Evaluation.
- · Survey Research.
- Organizational Change.
- Strategic Economic Planning (Power Sector, Local Institutions etc.)
- Social Sector Re-engineering (Health, Gender Issues and Education)
- · System Study, Design and Development.
- Library Organization & Automation.

At present, the following projects are underway at HIPA:

- (i) Access to Information Project on RTI, funded by DoPT -UNDP (ongoing)
- (ii) Sevottam Cell at HIPA sponsored by Department of Administrative Reforms and Public Grievances, Government of India.
- (iii) Project on Capacity Building for Access to Information

HIPA has been selected as the State Implementing Agency (SIA) by DoPT, Government of India under the UNDP Project "Capacity Building for Access to Information". The project inter-alia aims at strengthening the mechanism for improved Government-Citizen interface to enable capacity building for access to information through training initiatives.

The project is being implemented in two districts of the State. The objective is to demonstrate improved performance and responsiveness to citizens' demands for information. This would serve as a model of the best practices and a motivational set up for other districts to replicate the efforts.

Academic Contribution of HIPA Faculty in a Nutshell

To achieve the mandated objectives of the Institute the faculty contributes through training, research and consultancy in a large number of applied area within the broad specialization of their discipline. The academic contribution is mainly through customized long and short term training for enhancing professional efficiency through Information and Communication Technology, IT application in governance, service delivery and process reforms. It also covers MIS applications for areas like HRM, e-Office and GEM etc. The faculty has developed internal capacities in the emerging areas of social, economic and administrative concerns including environment, renewable and alternative sources of energy, and emerging trends in Indian and global administrative innovations, democratic decentralization, multi-level planning, grassroots level development administration, etc.

The faculty have carved a niche for themselves in the highly incipient areas like geo-spatial technology, safe construction, industrial and chemical disaster management, solid and liquid waste management, urban risk reduction, emergency medical response and psycho-social care in disaster situation. Our faculty have developed specialized courses for civil services at various levels for capacity building in ethics and values in administration, continuous quality improvement and transparency in administration through right to information and sevottam modules. An addition to conducting internal courses the faculty is much sought after in peer organisations of national repute for training sessions and lectures in their domain expertise.

There is substantial academic recognition to the credit of HIPA faculty through publications of serial and monographs, case studies and research papers in the journals of national and international standing. They have been contributing to academic deliberations in various national and regional level seminars, symposia and workshops etc. in the Institute and other parts of the country.

Some of the important research papers presented at the seminars and published in the periodicals included — Leadership Skills; Emerging Trends in Global & Indian Political, Business, Religious Leadership; Skill Development in Haryana; Societal Contributions and Consequences in crime analysis; Bio-Medical Waste Management; Smog and Deteriorating Life; Pattern Recognition Inventory Model Using Soft Computing Techniques; Gram Panchayat Development Plan, Sustainable Rural Governance for Sustainable Development; Constitutional Safeguard for Women Security; Waste Water Governance; Women and Higher Education etc.

Case Studies in Governance and Innovation included *The Earth Saviours Foundation:*An Internationally recognized NGO; Waste Water Governance - A Case study of Baindi Village;
Direct Benefit Transfer (DBT) of Financial Assistance; Thari Pension Thare Pass etc.

Select research based studies conducted by the HIPA faculty in the year under review included: Use of Information Technology-Case of GMDA, Broadband Connectivity in Rural Haryana Issues and Challenges (A case Study of Ambala District); Role of IT in Improving the Service Delivery - A Case Study of Municipal Corporation, Gurugram; Doubling Farmers' Income in Haryana: Issues And Concerns, ; Meeting the Challenge of Effective Service Delivery to Citizen through Technology: SARAL Portal, Haryana etc.

SEMINARS, WORKSHOPS AND LECTURES

The Institute conducts seminars and workshops to facilitate frequent interaction among the administrators, academicians and professionals on various subjects of interest. HIPA conducted the following Seminars/Workshops during the period under review:

Seminar on Future of ICT in Governance

A half-day seminar on the Future of ICT in Governance was organized at HIPA in collaboration with Haryana regional branch of Indian Institute of Public Administration on April 10, 2019. Dr. Ram Sevak Sharma IAS (Retd.), Chairman of Telecommunications Regulatory Authority of India (TRAI) was the Chief Guest and the keynote Speaker. The event was presided over by the Chairman of Haryana Regional Branch of IIPA Shri M.C. Gupta IAS (Retd.), former Secretary to Government of India and former Chief Secretary, Haryana. Dr. G. Prasanna Kumar IAS (Retd.) Director General, HIPA delivered the welcome address. Dr. Charu Malhotra, Associate Professor, IIPA presented a paper on the theme. It was attended by the training participants, faculty of HIPA and the members of the Regional Branch in a large number.



Two-day Workshop on Good Governance and Sustainable Development Goals

The Institute of Public Administration, in collaboration with Indian Institute of Public Administration, Haryana Regional Branch organized a two-day workshop on Good Governance and Sustainable Development Goals on October 03 & 04, 2019 at HIPA, Gurugram. The workshop was organized with an objective to provide a platform to the practitioners, academicians and administrators to learn from the Best practices, sharing of various SDG driven initiatives with Good Governance. The workshop was attended by members of IIPA Haryana Regional Branch (HRB), Haryana Development Forum, retired and serving officers of Centre and State of Haryana, trainees and Faculty of HIPA along with students from Government College for Women, Sector 14 and Dronacharya Government College, Gurugram. Dr. Rajvir Dhaka & Dr. Manveen Kaur coordinated the workshop. Dr. G Prasanna Kumar, Director General HIPA & Vice Chairman, IIPA (HRB)

delivered the welcome address and briefed the participants about the importance of the workshop. Dr. Prasanna Kumar, quoting Gandhiji's famous talisman, told the youngsters that they now have a new talisman, the SDGs. Shri M.C. Gupta IAS (Retd), former Chief Secretary to Government of Haryana and currently Chairman, IIPA, HRB stressed that adoption of SDGs is a transformative change and the most significant initiative to eradicate poverty. Presenting the concept paper on Good Governance and UN Sustainable Development Goals, Dr. C. Sheela Reddy, Professor, IIPA, highlighted the aspects of MDGs and SDGs and differentiated responsibilities associated with these. She explained the way governance could be integrated into SDGs by adopting Whole of Government Approach 2030 Agenda that has to be embraced holistically. She also articulated the related challenges and laid out recommendations for the road ahead. The first day of the workshop was focused on a common thematic area of SDG and Good Governance. Further, the workshop highlighted the four SDGs out of 17 SDG i.e. Poverty, Gender, Education and Health. The workshop initiated with the focused discussion on Achieving Sustainable Development Goals through Good Governance - National Perspective, Dr. P. K. Anand IAS, Consultant at RIS, Delhi and keynote speaker of the session highlighted the need for developing an effective government within a democratic system. Shri M.C. Gupta and Dr. G. Prasanna Kumar moderated the session. Other presentations included Gender Equality Achievements, Gaps and Future Challenges by Dr. Santosh, Statistical Advisor from Ministry of Women and Child Development (MWCD), Government of India. The UN perspective on Gender was presented by Ms. Radhika Mathur and Ms. Abhiruchi. Health for All by 2030- An Indian Perspective (the SDG-3) was presented by Dr. V.K. Srivastava, EX C.D., Ministry of Health and Family Welfare, Government of India; Approach to Quality Equity and Inclusion in Education - A Road to Sustainable Development by Prof. K. Ramachandran, a renewed Educationist, Professor at National University of Education and Planning (NUEPA) Delhi; and End of Poverty in all its forms everywhere by Prof. Shahid Ahmad from Jamia Millia Islamia (N.Delhi). The first session of the second day Localizing the Sustainable Development Goals, saw Shri Sanjay Pant, Director, Social Statistics Division, Ministry of Statistics and Planning, highlight the transition from "MDGs to SDGs" and the road map for achieving the SDG by using indicators to measure and monitor the progress. Shri Tarun Ahuja spoke on Awareness Generation and Capacity Building Lead from Haryana's SDGCC (Sustainable Development Goals Coordinator Centre of UN) and Swaran Jayanti Haryana Institute of Fiscal Management, presented an overview about SDG, State Level Indicators and their outcome. Ms. Divya Jyoti (Faculty member, HIPA) proposed a vote of thanks to all the dignitaries and participants for making the workshop success as an event of national importance.

Seminar on Air Pollution in NCR: Causes & Remedies

The Institute in collaboration with Indian Institute of Public Administration (IIPA), Haryana Regional Branch and Haryana Pollution Control Board organized a Seminar on "Air Pollution in NCR: Causes & Remedies" on December 02, 2019. Dr. C.K. Varshney, the eminent environmentalist spoke about the challenges in ecology and environment conservation.

Shri M.C. Gupta, Chairman of the IIPA Haryana Regional Branch and former Chief Secretary Haryana, delivered the keynote address. Dr. G. Prasanna Kumar, DG Haryana Institute of Public Administration presided over the proceedings. The Seminar was coordinated by Dr. Rajvir S. Dhaka. The experts attending the seminar were unanimous on the view that the recent escalation in the pollution levels is alarming which calls for a long-term strategic policy intervention aimed at reducing air pollution at the source which could also support a nation-wide vision for sustainable development. The workshop also highlighted the action area and focused on the policy guidance through panel discussions and consultation by experts.

Lecture by Prof. Dai-Yeun-Jeong, Director, Asia Climate Change Education Centre

Prof. Dai-Yeun-Jeong, Director, Asia Climate Change Education Centre, Jeju, South Korea and an emeritus Professor at Jeju National University, South Korea delivered a lecture on 09.12.2019 on "How to Overcome the Limitation Inheritance in Sustainable Development". A compost plant was established at HIPA which was inaugurated by the DG on 21.9.2018. Here a mixture of leaves, grass clippings and vegetable peels are decomposed into organic fertilizer to be utilized for the plants and lawns of the campus. This is another step towards "Clean HIPA, Green HIPA". It is an initiative taken by the Institute considering the need of the hour. The Compost plant has been running successfully since its installation.





Solar Energy

Energy is the basic requirement of mankind. The challenges of climate change and global warming increasingly impact our community. Haryana has been an undisputed leader in industrial development and energy saving and to achieve energy efficiency has been one of the major objectives of the state government. Recognizing the crucial importance of renewable energy, Haryana Institute of Public Administration, Gurugram has installed grid connected rooftop power plant having capacity of 100KWp to save the energy of the Institute. The Solar Power Plant was installed in HIPA on 07.1.2019 from the Department of Renewable Energy, Government of Haryana. HIPA has already saved 70,437 units in a short span of time.

AMENITIES AND INFRASTRUCTURE

The Haryana Institute of Public Administration (HIPA), earlier located in a rented building at Chandigarh, shifted to its own campus in 1993 at Plot No. 76, Sector -18, Gurugram. The present campus of HIPA is spread in more than 7.5 acres with a lush green cover. Location wise, HIPA is just 10 kms. away from Indira Gandhi International Airport, Delhi.

HIPA has a four-storeyed building with an excellent infrastructure consisting of seven class-rooms equipped with modern training aids, two computer labs, a GIS lab, a spacious auditorium and a conference room.

The Library & the Information Centre of the Institute are equipped with a core collection of over 26,562 books pertaining to Social Sciences, Management and Literature. The Centre subscribes to almost all important Journals & Magazines of National and International repute.

Air-conditioned reading hall of the library provides conducive environment for study and researchwork.

The hostel of the institute is well-furnished and comfortable. It has a spacious dining hall and excellent indoor and outdoor sports facilities. The hostel can accommodate around 90 trainees at one time.

The Building of HIPA attracts visitors and participants alike. The campus is spread over 7.5 acres with a lush green cover. The campus consists of:

- Administrative Block
- Hostel
- Director General's residence
- Residential flats for faculty and other staff
- Academic area, comprising of a Seminar room, Auditorium, Class rooms and Computer labs etc.

The HIPA Complex provides round the clock service. It has well-furnished and work friendly rooms, a Conference Hall, an Auditorium, working areas as well as residential facilities for the participating officers. The complex provides boarding and lodging to the participants.

The staff from various disciplines are engaged in different tasks and functions to translate the goals into reality. Commitment, competency and a spirit of teamwork are fostered to realize the mission of the Institute.

ADMINISTRATIVE & TEACHING BLOCK

HIPA has a four-storeyed teaching and administrative building with good architectural design. There are comfortable offices for the staff. It has an Auditorium and seven well- equipped classrooms with multimedia facilities. Besides, there is a Board room for the Director General on the first floor.

HOSTELBLOCK

The hostel provides well-furnished and comfortable accommodation to cater to more than eighty trainees at a time. It has a spacious dining hall, with sitting arrangements for smaller groups. The kitchen/mess is fully equipped to serve quality meals to the participants who regularly visit the Institute for training programmes, workshops, conferences and seminars. High standards of hygiene, overall cleanliness and the quality of food are always maintained. Apart from this, there is a regular testing/servicing of water filters which have been installed in the mess area.

WELLNESS AND SPORTS

The trainees are encouraged to lead a rich and varied life at campus to give expression to their creative potential. To achieve this, they are provided with the facilities of a well-equipped gymnasium in hostel. It provides outdoor and indoor games facilities to the participants. The outdoor games include Eight Layers Tennis Court of International Standard, Basket Ball, Volley Ball, Football, Cricket etc. The indoor facilities include Billiards, Carom, Table Tennis, Chess, Squash and Badminton.

PT and Yoga classes are held regularly so as to provide the participants with the opportunities of an all-round development. Trained instructors conduct the classes daily.

LIBRARY

The Institute is committed to provide the widest possible access to information and this commitment is reflected in the range of services provided by the Library of the Institute. It is equipped with modern infrastructural facilities. Display systems of journals and arrival of new publications are very well – arranged. Over a period of time, the library has developed a well - balanced and updated collection of documents including books, periodicals, technical and research reports, modules etc.

Air-conditioned reading hall of the library provides perfect atmosphere catering to the needs of the research scholars, faculty and participants of various training courses. Most of the library-functions and services are computerized.

AUDITORIUM

The spacious Auditorium, called 'Gandhi Hall' in the main building of HIPA provides facilities for holding conferences, training programmes and seminars. The facilities created by this well-furnished and well- equipped Hall are so impeccable that they are availed by outside voluntary and corporate sectors also.

ICTAND COMPUTER LABS

HIPA has two computer labs on the second floor of the Teaching block. All the terminals are connected with internet facility. One GIS Lab is housed on the third floor of the building. To facilitate their work, all faculty members have been provided computer & printer facilities with internet in their respective offices.

ARCGIS-ARCEDITOR FACILITY

GIS-mapping is used for identification of hazards/vulnerability/capacity for effective management of disaster. This mapping is done by collecting latitude and longitude of resources such as cranes, trucks, fire stations, hospitals etc. which are represented on pictorial formats on digital maps.

GIS allows better understanding and viewing of physical features in the given geographical conditions. It can provide quick and comparative view of hazards with disaster prone areas at risk and therefore, can demarcate areas to be safeguarded. GIS provides spatial representation of hazards and vulnerable population on the map along with (spatial representation) resources that can be used for response and other disaster management related activities.

Following outputs can be generated using Arc GIS:

- Mapping vulnerable areas on digitalized maps.
- Spatial representation of resources.
- Guidance in damage assessments.
- Mapping High Risk Zones.
- Buffer areas around Rivers to identify flood prone areas.

MEDICAL FACILITY

In view of the importance of medical facilities in the campus, it was proposed that a dispensary for the inmates, be established within the complex. As per the decision taken in the 55*meeting of Executive Council of HIPA held on 09.6.2009, a dispensary was established at the hostel of the institute.

The services of one Doctor and one Pharmacist are available everyday for two hours to provide basic medical facilities to the staff of HIPA, their families and the participants.




