- b) e-Billing: Being used for preparation of all types of bills like Salary, Contingency, TA, Medical, Refund etc.
- c) Online Treasuries Information System (OTIS): Being used for automation of processes in treasuries and its interface with banks, AG office, NSDL and Income Tax department, management of stamps inventory.
- d) e-Pension: Being used for disbursement of pensionary benefits to the state pensioners.
- e) e-GRAS: Being used for receipt of all sorts of government revenue and e-Stamping.

### **E-OFFICE**

### **Project Brief**

e-Office is a mission mode project under the National eGovernance Plan. It aims at significantly improving the operational efficiency through improvement in the workflow mechanisms and associated office procedures. Government has decided to implement e-Office in all Departments, Boards, Corporations & its subsidiaries upto District Level to improve efficiency, consistency and effectiveness of government responses.

### **Current Status**

E-Office has been implemented in 124 Departments/ Boards/ Corporations and 22 DC offices under two instances i.e. Sachivalaya & PSU instances.

More than 32000 users have been enrolled under e-office.

Approx. 823067 files have been created and the file movement is approx. 6401018.

Total Infrastructure and Management Cost per Annum approved in e-Office DPR is approx. Rs.5,91,98,392.

### **Future Roadmap**

Current version 5.x is to be upgraded to the latest version 7.x.

# **ICT-EXAMINATION (ICT-ET)**

### **Project Brief**

The State Government has authorized HARTRON for conducting the SETC Test/exam for Government employees on their behalf. The SETC Test/Exam consist of Two Parts:-

Part-I: - An objective type Computer Knowledge Test with pass percentage as 50%.

Part-II: Typing test will be conducted of such candidates only, who will pass the Computer Knowledge Test (Part-I) or who is exempted under notification dated 07.11.2013 & order dated 22.09.2017.

#### **Current Status**

Up to July 2022, 80+ SETC Test/Exam has been conducted successfully and recently SETC Tests were being conducted at HMSDC Gurugram and IDDC Ambala Cantt. In the month of August 2022. Moreover, as per instruction of CS Office, the SETC test is conducted on monthly basis






